SPRING 2008 SEASON COMMITMENTS

FUNDRAISING

(IN ADDITION TO REGISTRATION FEES)

The registration fee is part of the commitment required to participate in the choir.
It is estimated that it will take approximately \$200 per singer, each season, to fund the choir program.
The balance is made up with fundraising events or a one time per season buyout.

OPTION 1: ___ I promise to fulfill my fundraising commitment by participating in fundraising activities & pay balances by April 11, 2008. I understand there is \$25 additional fee if balances are paid after April 11, 2008.

before 4/01/08 One singer in family registered = \$100 2 singers in immediate family = \$175 3 or more in immediate family = \$250
after 4/01/08 One singer in family = \$125 2 singers = \$200 3 or more singers = \$275

OPTION 2: ___ I prefer a one time buyout (this season) as listed below:

after March 1, 2008 one singer in family = \$125 2 singers = \$200 3 or more singers = \$275

OPTION 3: ___ I prefer a combination of both fundraising and buyout (to be completed by 4/01/08 - see amounts above)

*Unfortunately the choir cannot exist without funds raised by our families.
Unless there is an extreme financial hardship, in which prior arrangements have been made,
ALL fundraising must be paid prior to concert dates.
Singers that have outstanding balances at the time of concerts
WILL NOT BE PERMITTED to participate until balances have been paid in full.*
